DEPOSIT. A non-refundable deposit of \$100 must be submitted in addition to this contract in order to complete booking. Deposits can be submitted on my website, or directly from Paypal to erica@hauteharpist.com or mailed to PO BOX 2071 San Mateo, CA 94401. **Balance payment is due two weeks prior to performance date. For events outside of the San Francisco Bay Area, balances must be paid in full at time of booking.**

AMPLIFICATION. A multi-directional Bose sound system is included at all performances. Erica will need access to a two outlet power supply. Please provide extension cords and electrical tape if necessary to prevent tripping on cables. For audiences larger than 100 persons, the client is responsible for providing professional audio amplification and a four speaker PA system is recommended. **Initial here:**

SURFACES. The harp cannot be in rain, mist, fog, drizzle, extreme temperatures or direct sunlight. The harp must be on a flat, smooth surface. No inclined surfaces, grass, wood chips, gravel, etc. **at a minimum of 5 feet away** from foot traffic, food and beverages. Please provide at least a 5x5 area for music stand, harp, bench, and speaker.

If above requirements are not met, and alternate arrangements are not made 30 minutes before performance start time, NO refunds shall be given and Erica will be unable to perform.

SETUP: Set up and break-down takes approximately 20 minutes. If this process needs to be expedited, please provide crew to assist.

CANCELLATION: In the event of cancellation by _____ within one week of scheduled performance, Erica will retain 50% of balance paid. However, the event can be rescheduled within three months at no additional fee. If cancellation by Erica occurs at any time, all monies paid to Erica Messer will be refunded. In the event that Erica is unable to perform due to illness or injury, a substitute will be sent if possible.

AMENDMENT. This Contract may be modified or amended in writing, if the writing is signed by the party obligated under the amendment.
